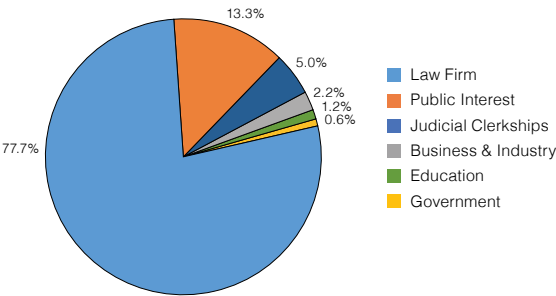

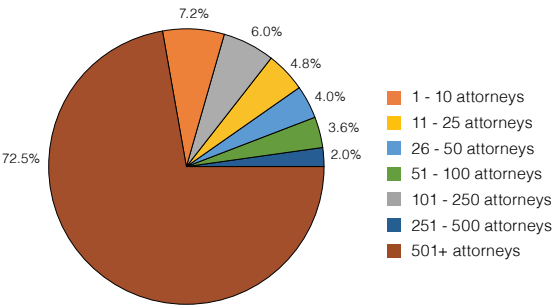
EMPLOYMENT
