## The Fresno County Bar Association's

### 2024 Scholarship Award For First, Second, Third- and Fourth-Year Law Students

(Up to \$2,500 Award)

To be Awarded by The Fresno County Bar Association's  
Memorial Scholarship Fund

#### **Application Deadline: December 15, 2024**

The Fresno County Bar Association ("FCBA") announces its 2024 Scholarship Award from the Fresno County Memorial Scholarship Fund, established in 1966 to provide grant monies to law students residing in Fresno County. Law students meeting the requirements listed below may submit applications until end of quarter, to be considered for the Award.

#### Award Eligibility Requirements:

- Applicant must have been accepted to law school or currently be in their First, Second, Third and Fourth year of law school, must have demonstrated legal aptitude, and must be in good standing at a school of law in California that is accredited by the State Bar of California.
- The Committee shall recognize that the expense of legal education may impose hardships upon the families of applicants of average or higher incomes or means, as well as upon those of limited incomes, and that assistance to persons of such backgrounds may be necessary or desirable for their legal education, result in improved academic work, improve the qualifications of such persons for the practice of law, and their ability as practicing attorneys.
- The Committee shall recognize that while a high undergraduate scholastic record may aid in determining qualifications for the future practice of law, such considerations, among others, as emotional stability, sound judgment, ability to reason, legal aptitude, and leadership are factors in determining the future competency of an applicant as a practicing attorney, and their determinations shall not be based solely upon the undergraduate scholastic records.

- Applicant must be a resident of Fresno County. (A law student attending a State Bar of California-accredited law school in California located outside Fresno County is eligible to apply if his or her permanent family residence address is located in Fresno County, California.)
- Applicant must complete the FCBA's 2024 Scholarship Award Application form and mail the completed form and attachments to:
