YOU ARE INVITED to participate in **UCLA SCHOOL OF LAW'S 2022 On-Campus Interview Program** (OCI) which will be held in two sessions, Early Interview Week and Fall Interview Program. In an effort to enhance your interviewing experience, **we are pleased to offer you the ability to prescreen up to 30% of your interview schedule** with the balance being assigned via lottery. **BOTH SESSIONS WILL BE HELD REMOTELY USING THE FLO RECRUIT PLATFORM.**

- **Early Interview Week, 2022: July 26 - July 29**, remotely using Flo Recruit platform.
 - Registration is now open with a deadline of July 1, 2022
- **Fall Interview Program, 2022: September 14 - September 16**, remotely using the Flo Recruit platform
 - Registration is now open with a deadline of August 15, 2022

OCI provides an opportunity to recruit the **best and the brightest students** from the Class of 2024 for summer positions and from the Class of 2023 for post-graduate positions, all of whom are well equipped to immediately add value to your organization. In fact, the vast majority of UCLA law students engage **in professional skills training**. Further, all UCLA law students engage in experiential skills training, in accordance with the ABA experiential requirement, but many exceed the ABA requirement.

HOW TO REGISTER

To participate in Early Interview Week or Fall OCI, log on to [UCLA's Symplicity site](#). If you do not have a UCLA Symplicity account, you will be able to register for one on this site.

- **If you interviewed at UCLA School of Law during 2021, you will be asked to complete the results of that experience prior to registering for OCI.** If you did not interview at UCLA last year, please answer accordingly.
- **If you had a Summer Program, you will also be asked to give us feedback from that session.**
- Registrants will be assigned on a first-come, first-served basis within your chosen session.
- If you would like to coordinate schedules with USC and/or Berkeley, please indicate with which school(s) you would like coordination.
- **REGISTRATION FEES**
 - 1-50 lawyers: \$250 per schedule
 - 51-100 lawyers: \$600 per schedule
 - 101+ lawyers: \$750 per schedule
 - Businesses - \$500 per schedule
 - Public Interest organizations and Government agencies: no fee
