Steps to register for OCI virtual interviews. Please visit <u>Symplicity</u> starting on **February 28**th to schedule your request under the OCI tab. If you have questions or need assistance setting up your schedules, please email Carmen Torres at <u>TORRES@law.ucla.edu</u>.

- 1. Log into <u>Symplicity</u>. If you do not have a UCLA Symplicity account, you will be able to register for one on this site by clicking "Sign Up".
- 2. Click on OCI (found in left hand navigation toolbar)
- 3. Click on Request Schedule. Please note, you will be asked to complete the Summer and OCI Feedback Surveys if you haven't done so already.
- 4. Complete form making sure to select the correct session from the Sessions drop down menu (Early Interview Week 2023).

When registering, please note:

- Dates will be assigned on a first-come, first-served basis, and we will be prioritizing equitable distribution of employers across our interview days. We will try our best to accommodate your requests.
- When you register: You will be asked a few questions about your OCI hiring needs. If your hiring needs change, please contact <u>Carmen Torres</u>.

Registration fees & cancellation

1-50 lawyers: \$250 per schedule
51-100 lawyers: \$600 per schedule
101+ lawyers: \$750 per schedule
Businesses: \$500 per schedule

• Public Interest organizations and Government agencies: no fee

Please note employer size is based on total number of lawyers across the firm or organization, not within a particular office. Employers that <u>cancel by June 30, 2023</u>, will receive a 50% refund of their registration fees. For later cancellations, registration fees will not be refunded.

Resume and Application Collect Sessions

Employers, including those considering candidates early and/or those unable to join us for OCI, have the option to participate in the following document collections through Symplicity. Employers may reach out directly to participating students at their convenience to schedule screening interviews during the summer. Registration is through Symplicity's OCI tab under the Sessions drop down menu, and there are no fees to participate in these document collections.
