UCLA Law's Center on Reproductive Health, Law, and Policy; the Office of the Los Angeles City Attorney; the Los Angeles County Bar Association; and the Women Lawyers Association of Los Angeles—together with law firms, government agencies, and advocacy organizations—have come together as the Southern California Legal Alliance for Reproductive Justice (SoCal LARJ).

SoCal LARJ secures free legal representation for reproductive health providers, patients, and advocates on a wide range of legal matters including: civil and criminal matters affecting access to abortion and other reproductive health care, risk management, compliance with applicable laws and regulations for provision of health care, business and contract law, copyright law, and employment law.

### Our Impact and Intent

Health care providers, patients, and support organizations face a growing array of draconian restrictions following *Dobbs*. These restrictions carry civil and criminal penalties and create urgent legal questions. Founded in 2023 and managed by CRHLP, SoCal LARJ was created to meet this need. This work includes:

- Providing **pro bono legal support** to health care providers, patients, advocates, and organizations.
- Launching and managing a **dedicated legal hotline** staffed by experienced lawyers.
- Matching health care providers, patients, and advocates with top local and national law firms—**over 50 firms have joined** to support a broad range of legal matters.
- Addressing over 70 legal matters to date, ensuring rapid, informed support for providers, patients, and advocates.
- Offering **training and resources** for lawyers, including those new to reproductive rights and justice work.
- Coordinating with allied coalitions and organizations to ensure legal resources **strengthen, rather than duplicate, existing efforts**.
