FAREWELL TO THE GRADUATES

PRESIDENT AND DIRECTOR-COUNSEL OF THE NAACP
LEGAL DEFENSE FUND

Janai S. Nelson is President and Director-Counsel of the NAACP Legal Defense and Educational Fund, Inc. (LDF). As an organizational thought-leader at LDF, Ms. Nelson determines and executes LDF's strategic vision and oversees the operation of its programs. A member of LDF's litigation and policy teams, Ms. Nelson's extensive civil rights law experience includes expertise as a voting rights and election law scholar, serving as one of the lead counsel in *Veasey v. Abbott* (2018), a federal challenge to Texas's voter ID law, hair discrimination advocacy, and testifying before Congress multiple times on issues ranging from voting rights and election law to discriminatory practices and procedures administered by TSA.



Prior to joining LDF in June 2014, Ms. Nelson was Associate Dean for Faculty Scholarship and Associate Director of the Ronald H. Brown Center for Civil Rights and Economic Development at St. John's University School of Law where she is also a full professor of law. Ms. Nelson received the 2013 Derrick A. Bell Award from the American Association of Law Schools (AALS) Section on Minority Groups and was named one of Lawyers of Color's 50 Under 50 minority professors making an impact in legal education. Prior to joining St. John's faculty, Ms. Nelson was a Fulbright Scholar at the Legal Resources Center in Accra, Ghana. She began practicing law as the 1998 recipient of the NAACP LDF/Fried Frank Fellowship, following federal district and appellate court clerkships. Ms. Nelson later became Director of LDF's Political Participation Group, overseeing all voting related litigation and matters, litigating voting rights and redistricting cases, and working on criminal justice issues. Ms. Nelson has published scholarship in leading law reviews and writes for popular press. She has appeared in various media as an expert on race, civil rights, constitutional law and election law, and regularly speaks at conferences and symposia nationwide. She is a graduate of New York University and received her J.D. from UCLA School of Law.

LIA VANATTA

January 6, 1996 – January 23, 2020

Lia Vanatta was an outstanding member of the J.D. Class of 2022 who passed away the morning of January 23, 2020, from a long-standing heart condition. By all accounts, Lia loved her first semester of law school, developed quick friendships, and thrived in the classroom. She is fondly remembered by many, including her Section 2 and LRW Section C peers and faculty.

Lia grew up in San Jose and was a graduate of Vanderbilt University, where she earned a B.S. in Computer Science. She worked as a legal secretary at Gibson, Dunn & Crutcher in the Bay Area before pursuing her studies at UCLA Law. At UCLA Law, she volunteered in the El Centro Legal Reentry Clinic and the Public Counsel CARES Clinic.

Based on her academic performance in the Fall 2019 semester, the Law School designated Lia as an honorary Michael T. Masin Scholar. The Masin Scholars Program annually recognizes those students who achieve the 12 highest grade point averages after the first year. The Law School had every reason to trust Lia would have continued to perform at the highest academic levels and would have joined the Masin Scholars cohort. Her official academic record includes this designation.

Lia's family held a Celebration of Life for Lia on February 9 in Los Gatos, California. Friends, family, and loved ones—including several UCLA Law classmates—shared the many ways in which Lia affirmed them, made them laugh, challenged them, and demonstrated her strength and kindness.
