Due to limited funds and increasing prices, the law library no longer subscribes to print versions of most materials available to our faculty and students through their Lexis and Westlaw accounts.

- Confirm that a resource is available at the law library.
- Let you know in advance if a resource is not available at the law library and recommend alternative resources.

Most Popular Database

The UCLA Law Library database most commonly used by attorneys is **NexisUni**, a simplified version of Lexis that provides access to:

- Case law, statutes, and regulations for all 50 states and the federal government
- Shepard's citator
- Law review articles and a small selection of other secondary sources, including the **American Jurisprudence** encyclopedia.

Accessing Commonly Used Databases

From anywhere on campus: The following commonly used databases can be accessed from a laptop connected to UCLA_WEB (at the law library or anywhere on the UCLA campus), as well as from the public access computers in the law library's reference reading room:

- NexisUni
- HeinOnline
- VitalLaw

From the law library only: The following commonly used databases can be accessed only from the public access computers in the law library's reference reading room:

- CEB OnLaw
- Fastcase
- PLI Plus

Attorneys may also want to consider visiting the LA Law Library, a public law library focused on providing support for attorneys and other members of the public. It offers a large collection of print resources, as well as two hours per day of on-site access to **Lexis**, **Westlaw**, **Fastcase**, **HeinOnline**, and other databases.

The LA Law Library's main location is in downtown LA at 301 W. First Street. It also has several conveniently located partner branches, in areas such as Santa Monica, Pasadena, and Van Nuys.
