About CRHLP: The UCLA Law Center on Reproductive Health, Law, and Policy (CRHLP) is a think tank and research center developing long-term, lasting solutions that advance all aspects of reproductive justice and address the current national crisis of abortion access. We are lawyers, policy experts, scholars, and researchers who are working to increase access to abortion and contraception, end racial and economic disparities in maternal health outcomes, support people who decide to build families, and dismantle the gender bias that limits reproductive justice. We do this as a national hub for legal innovation and frontline support in reproductive justice. Since our founding, we've taken urgent action to provide lawyers to patients and providers, trained the next generation of reproductive rights advocates, and convened stakeholders on building long-term legal strategies to fight back against attacks on reproductive health care, gender equity, and to address barriers to maternal health and family building. Law Fellow Role: Whether you want to help conceptualize bold legal theories and cutting-edge scholarship, or help people who contact our legal helpline, or both, the Law Fellow role is for you! The ideal candidate will have excellent analytical and research skills, and be a creative thinker who is detail oriented, excited to join a university-based think tank, and committed to advancing reproductive rights, health, and justice. The Law Fellow will be an integral member of CRHLP and work very closely with all members of the legal team (including the Legal & Policy Director, two staff attorneys, and law student externs) as well as regularly collaborating and engaging with our Executive Director and interdisciplinary research team

This is an internally funded, one-year post-graduate fellowship (approximately Sep. 2026-Sep. 2027) only open to UCLA Law students graduating in May 2026 and recent UCLA Law graduates. This is a hybrid position based in Los Angeles, California, with two days in office. Applicants must be admitted to a state bar or planning to take a state bar exam by August 2026.

**Responsibilities:** Dependent on candidates' interests and strengths, as well as CRHLP's needs during the fellowship year, primary responsibilities may include:

- Tracking and analyzing litigation, legal decisions, and policy developments to update and inform priority projects and future work, including CRHLP resources on state shield laws, litigation and federal action related to regulation of mifepristone, and state constitutional protections for reproductive freedom and equality.
- Conducting research to help develop arguments, theories, and analysis for building stronger constitutional doctrine on reproductive autonomy including as it relates to abortion; contraception; maternal health and birth justice; young people's sexual and reproductive healthcare; fertility care; and overcoming discriminatory and systemic economic, gender, and racial bias.
- Helping health care providers, patients, and support organizations access free legal assistance through the Southern California Legal Alliance for Reproductive Justice legal helpline and pro-bono network.
- Contributing to the development and coordination of convenings, symposia, and educational events that feature and reach scholars, researchers, lawyers, government officials, reproductive health providers, and advocates.
- Helping draft legal analysis and content for the Center's public-facing legal resources, newsletter, and for publication in legal, policy, scholarly, or other relevant outlets or journals.
- Contributing to researching, coordinating, and drafting amicus briefs or regulatory comments.
- Representing the Center at meetings, convenings, and panels oriented to the law school, the UCLA community, and local partners and supporters.
- Supervising, mentoring, or supporting legal interns as needed.
